(a) The main object of the Trust is to render philanthropic and educational services to the Telugu Linguistic public who are living in villages and who suffer from social and economic backwardness.

(b) To serve the cause of rural and community development by giving technical education to the rural local people by starting Engineering College, Polytechnic and other educational institutions and to pave way for substantial industrial prosperity.

(c) To provide fair opportunities to the middle class Telugu and other community students for the Madras and Chengai M.G.R. Districts to pursue their technical education without any economic and other difficulties.

4. Trust Fund :

The founder hereby declares that a sum of Rs.1,001/- (Rupees One thousand one only) handed over in Trust and dedicated for public educational purposes, shall be held by the Trustees upon Trust and also any their money or properties which the Trust may acquire from time to time for augmenting the Trust Fund.

5. The Founder Trustee :

The founder trustee shall be Mrs. Manjula Munirathnam, W/o. R.S. Munirathnam, residing at No.2981, Z Block, I Street, 13th Main Road, Anna Nagar, Madras - 600 040. The founder trustee shall hold office for life. She is entitled to nominate her successors who shall hold office for life with similar power of further nomination. The founder trustee nominates 1) Mr. R.S. Munirathnam, son of R. Swaminatha Naidu, 2981 - Z Block, Ist Street 13th Main Road, Anna Nagar, Madras-600040 and 2) Srimathi. Loganayagiammal, wife of R. Rajendran, 16-Lakshmi Road, Shenoy Nagar, Madras-600030 as Trustees. The two trustees nominated by her shall hold office for life. The founder trustee shall have the power to nominate more trustees from to time for such period or periods as the nomination may provide and the Founder Trustee will also have the power to remove the trustees so nominated by her expiry of the period for which they were nominated.

6. (i) The Founder Trustee shall be the Managing Trustee

(ii) The Founder Trustee/Managing Trustee shall open the bank accounts wherein shall be deposited all money and contributions received by the trust and maintain the bank accounts. The Managing Trustee shall cause to be maintained proper books of accounts required by law and therein shall be entered a true record of receipts and expenditure of the Trust. The books of accounts shall be subject to audit periodically by a qualified Chartered Accountant.

(iii) The Founder Trustee/Managing Trustee shall be person to act for and on behalf of the Trust and to open and operate independently the bank accounts and to receive and to pay money on behalf of the Trust.

(iv) The Founder Trustee/Managing Trustee shall have power to borrow funds for implementing and carrying out the objects and purposes of the trust from banks or other financial institutions, on the security or without security on such interest prevailing in the banking institutions and to execute necessary security documents on behalf of the Trust for such borrowings.

(v) The founder trustee/managing trustee shall be competent from time to time to frame, make and enforce all such rules, regulations and or bye-law not inconsistent of the express provisions of this trust as the Founder/Managing Trustee may deem proper for securing and facilitating the administrating and management in detail of the various activities and affairs of the Trust and for convening, conducting and regulating the meeting of the Trustees and for appointing sub-committees and generally for the Management and Administration of the Trust Estate and also from time to time to repeal, alter, amend, rescind or add to all such rules.

(vi) The Founder Trustee/Managing Trustee shall have power of authority to appoint or engage and to their discretion remove, dismiss or suspend any of the officials or employees or servants in permanent or temporary or special service in connection with the deed of trust as they may from time to time think fit and to determine their powers and duties and fix their salaries, bonus, or allowances and to acquire security in such instance and at such amount as the managing trustee may think fit. The founder trustee/managing trustee shall also have power to found and maintain provident funds, gratuity funds, personal and other funds for any employee and make rules and regulations regarding the same.

(vii) For the purposes of carrying out the object of the trust, the founder trustee/managing trustee shall have the power to acquire by purchase or on lease or otherwise any immovable property or any tenure and in case of vacant land, the managing trustee shall at liberty to erect building thereon and do all acts necessary and incidental thereto.

(viii) It shall be lawful for the founder trustee/managing trustee to pull down, renovate, re-build, alter, adapt, improve, add to, develop or repair any immovable property comprised in the trust properties and to expend thereon such money out of the trust fund or that income thereof as they may think fit.

(ix) The founder trustee/managing trustee shall be entitled to enter into any agreements or covenants with owners or person, entitled to or interested in any other properties and raise funds by way of loan by entering into agreements with any bank or banks or any other financial institutions.

(x) The founder trustee/managing trustee shall have power to make donations from the trust properties to carry out the object of the trust and not contravening clauses herein above.

7. Financial Year :

The accounts of the trust shall be closed on the 31st December every year and statement of income and expenditure and assets and liabilities shall be drawn at the date which shall present as true picture of the affairs of the trust.

The trust may receive contributions and donations in cash, cheques or any kind and also immovable properties, valid receipt shall be issued for all donations received. The trust funds shall be invested for the betterment of the trust in any manner as the founder/managing trustee deems fit including the cash securities as recognized by the Income Tax Act in force from time to time for the use of the trust.

8. Meeting of the trust :

The founder trustee shall call for a meeting of the Trust Board once in three months by giving seven days notice. The quorum on such meeting shall be TWO including the founder trustee.

9. Alteration of the benefits conferred by the Trust :

In the event of change of circumstances making it impossible to continue any of the schemes of the trust, the managing trustee shall apply the trust funds and the property to any other subject of like nature or to any other institutions or trust having similar objects.

WHEREAS Smt.M. Manjula, wife of Shri. R.S. Munirathinam executed a Deed of Declaration of Trust, on 01-07-1994, registered as Doc.No.1175 of 1994, in the office of the Sub-Registrar, Anna Nagar, wherein she as the Founder Trustee was also appointed as Managing Trustee and Shri. R.S. Munirathinam and Smt. Loganayakiammal were appointed as Trustees of the Trust.

WHEREAS the Trust was established as Telugu Linguistic Public Educational Trust and has been running Engineering Colleges, Polytechnic and Schools.

WHEREAS the Founder Trustee/Managing Trustee, Smt.M. Manjula passed away on 07-04-2011 and the powers vested with her ie, operation of Bank accounts

including loan accounts were transferred to Shri. R.S. Munirathinam, Chairman and Trustee of the Trust, vide a Resolution passed in the meeting of the Trustees of the Trust, held on 26-04-2014.

WHEREAS Smt. Loganayakiammal resigned her office of Trustee with effect from 05-10-2011, and her resignation was accepted by the Trust, in a meeting of the Trustees, held on the same date.

WHEREAS in the meeting of the Trustees of the Trust, held on 10-02-2011, Shri R.M. Kishore was appointed as a Trustee of the Trust.

WHEREAS thus the Trust has two Trustees at present, Shri R.S. Munirathinam and Shri R.M. Kishore.

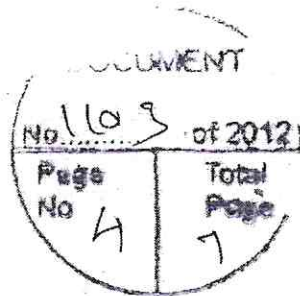
WHEREAS though the above stated appointment, resignation and authorization to operate Bank accounts and loan accounts were all recorded vide resolutions of various meetings of the Trustees, it is felt that necessary amendments to the Trust Deed should also be made in order to carry on the activities of the Trust more effectively, in the field of education.

NOW THIS DEED OF AMENDMENT TO THE TRUST WITNESSETH AS FOLLOWS:

1. Clause 5 in Page No.4 of the existing Trust Deed dated 1st July, 1994 reads as follows:

“The Founder Trustee shall be Mrs. Manjula Munirathinam, wife of R.S. Munirathinam, residing at No.2981, Z-Block, 1st Street, 13th Main Road, Anna Nagar, Chennai – 600 040. The Founder Trustee shall hold office for life. She is entitled to nominate her successors who shall hold office for life with similar power of further nomination. The Founder Trustee nominates

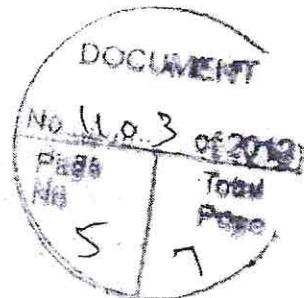

- (ii) Smt. Loganayakiammal, wife of R. Rajendran, No.16, Lakshmi Road, Shenoy Nagar, Madras - 600 030,

as Trustees. The two Trustees nominated by here shall hold office for life. The Founder Trustee shall have the power to nominate more Trustees from time to time for such period or periods as the nomination may provide and the Founder Trustee will also have the power to remove the Trustees so nominated by her expiry of the period for which they were nominated".

By this Deed of Amendment, the above stated clause has been amended as:

Shri R.S. Munirathinam, son of R. Swaminatha Naidu, residing at Plot No.2981, Door No.83, 1st Street, Z-Block, 13th Main Road, Anna Nagar, Chennai - 600 040 shall be the Chairman and Managing Trustee of the Trust. He shall hold such office till his lifetime. Shri R.M. Kishore shall be a Trustee of the Trust. He shall also hold such office for life. The Chairman/Managing Trustee shall have the power to nominate Trustees, from time to time for such period or periods as he shall think necessary for the functioning of the Trust.

- 2. Clause 6 (i), (ii), (iii) and (iv) of the existing Trust Deed dated 1st July, 1994 deals with the Founder Trustee / Managing Trustee's power to open the Bank accounts, to operate the same and to borrow funds from banks and financial institutions, to offer necessary securities for such borrowals and execution of necessary documents on behalf of the Trust.

Vide this amendment, the word Founder Trustee / Managing Trustee in the original Deed of Trust shall stand altered as Chairman / Managing Trustee. All the powers vested in these clauses shall hereinafter be with Chairman / Managing Trustee, Shri R.S. Munirathinam.

- 3. The original Trust Deed dated 01-07-1994 also denotes various powers of Founder Trustee / Managing Trustee in Clauses 6(v) to 6(x), 7, 8, 9 and 10. All such powers shall hereafter vest with the Chairman / Managing Trustee of the Trust, Shri R.S. Munirathinam. *Corpus fund of the Trust at present is Rs.1001/-*

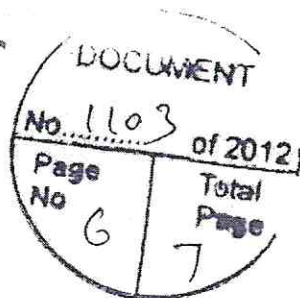

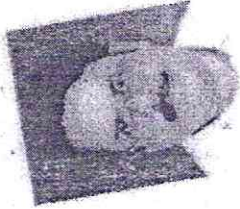
